Description of Planned Network Change(s):

Horry Telephone Cooperative (HTC) intends to retire copper facilities in the South Carolina locations listed in Exhibit A in order to respond to various factors in the Outside Plant, including road construction, maintenance problems, and growth accommodation. Replacement cables may be either coax or fiber.

Description of reasonably foreseeable impact(s) of the planned change(s):

After the retirement of copper facilities, copper facilities will no longer be available to serve customers at Exhibit A locations and will not be maintained. However, all services currently provided over copper facilities will continue to be provisioned over either fiber or coaxial facilities.
